

## *Instructions for Authors*

### **Quotations:**

For quotations within text, use **double quotation marks**. Single quotation marks should be reserved for quotes within quotes. Any material added to a quotation should appear in square brackets. Quotations longer than about three lines should be indented without quotation marks.

The full stop and the comma must be included within the quotation (./, ,”).

### **Arabic Transliteration System:**

The transliteration must use the following symbols:

Short Vowels	a, i, u

- ʾ (Hamza) should not be used in initial position:

Examples: *al-akhdh* not *al-ʾakhdh*, *Amīr* not *ʾAmīr*.

- The definite article:

Examples: *al-shams*, *al-kitāb*

- *Idāfa*:

Example: *Risālat al-Tarbīʿ wa-l-tadwīr*

- Prepositions preceding definite nouns and pronouns:

Examples: *fī l-madīna*, *bi-l-ʿaql*, *li-l-ṣāhib*

### **Capitalization:**

English book and article titles should have the main words capitalized, for example: *Anthropomorphism in Islam: The Challenge of Traditionalism (700–1350)*. For French, capitalize only the first word of the title even if it begins with an article: *L'oeuvre d'Abū Abd al-Rahmān al-Sulamī (325/937–412/1021) et la formation du soufisme*. Transliterated Arabic titles should be

capitalized as follows: *Kitāb (or K.) al-Shawāhid wa-l-amthāl, al-‘Umda fī maḥāsīn al-shi‘r waādābihi.*

**2. or shortened versions of bibliographical references:** Author's surname, *Book Title*/ "Article Title," page number.

If the bibliographical references is used, the reference list is no longer necessary. After the first reference to a source in the footnotes, further references consists of the author's surname, the book/article title and the page number. Where a further reference is made to a work cited in the immediately preceding note, use *Ibid.* and mention the page number (*Ibid.*, p.).

If the shortened versions of bibliographical references is used, please ensure that every reference cited in the text is also present in the reference list.

**Dissertations:** Author's surname, name. "Title." PhD diss., University, year.
