Why is this workshop important?

Poor decisions which are not informed by research evidence or based on improper interpretation of research evidence often have negative consequences on human lives and render those who make such decisions subject to criticism. Incorporating evidence into the policymaking process provides policymakers, policy advisors and managers the ability to make better decisions that can strengthen health systems and improve the health of citizens. Evidence-informed policymaking is an

approach to ensure that policymaking is well-informed by the best available evidence. Knowledge translation (KT) has gained prominence as an innovative approach bridge the gap between research and policy and promote evidence-informed policymaking.

This workshop will cover the concept and application of evidence-informed policymaking. Through interactive group activities, PowerPoint presentation, cases studies and simulation exercises, workshop participants will learn the fundamentals of evidence-informed policymaking, the range of KT tools and approaches available to promote the use of evidence in policymaking, and the methods to efficiently access and select research evidence. Effective tips will also be provided on how to communicate evidence (both published and tacit) with policy makers.

- Demonstrate enhanced skills in acquiring and applying research evidence in decision-making
- Demonstrate ability to develop policy briefs and convene policy dialogues
- Identify communication strategies and tools for reaching multiple audiences
- Practice ability to communicate with policymakers
- Advocate for evidence-informed and sound public health policies

Join K2P Center's workshop this March to learn more about evidence-informed policymaking, knowledge translation, communicating with policymakers, developing policy products and convening policy dialogues.

Objectives of workshop

Participants in this three-day workshop will be exposed to the following domains and discuss, based on specific examples, their relevance to their work:

- Existing knowledge about various approaches in evidence-informed policymaking;
- Existing resources available to health policymakers and stakeholders in order to support their use of research evidence;
- Knowledge translation tools, approaches and platforms to package research evidence for policymakers and support its use in decision-making;
- Developing policy briefs and convening policy dialogues;
- Finding and using research evidence efficiently;
- Effectively communicating with policymakers (verbal and written)

Format

The workshop will feature didactic material balanced with cases studies and interactive group assignments in addition to simulation exercises. We will use both case examples and participants' own projects and experiences as foundations for applied learning.

Additional reading material will be made available to participants as guiding matter.

His research activities, publications and interest are focused on health policymaking, knowledge translation, governance, performance reporting for health systems and organizations, quality of care, accreditation, patient safety, and human resources for health. He led several multi-country initiatives and projects in several countries and regions. He has published in international and regional peer review, high impact factor journals.

Dr. El Jardali has worked and held senior positions with policy analysis related organizations such as the Ontario Ministry of Health and Long-Term Care (as Hospital Consultant), Federal department of health / Health Canada (as Senior Policy Advisor) and the Health Council of Canada (as Health Economist and Program Manager).

He is a recipient of the Global Health Leadership Award and was elected twice to the Board of [Health Systems Global Society](#). He is also a recipient of the Fellowship on Evidence Informed Policy from the Alliance for Health Policy and Systems Research. He is the founding member of the MENA Health Policy Forum. He is an Associate Editor for BMC Health Services Research Journal and also a member of the Editorial Advisory Board for the Health Policy and Planning Journal. He is a member of the Global Steering Committee for the WHO Evidence-Informed Policy Network (EVIPNet). He is an appointed member of the Medical Research Committee Joint Health System Research Initiative Committee. He is a certified accreditation surveyor with Accreditation Canada and a certified ISQUA surveyor with the International Society for Quality in Healthcare.

Aida Farha has been working as a medical information specialist at the American University of Beirut since 1980. She holds a BS in pharmacy from the American University of Beirut. Her research interests include Medical Library and information, Social Sciences, Health Sciences, Library Science and Library and Information Studies.
